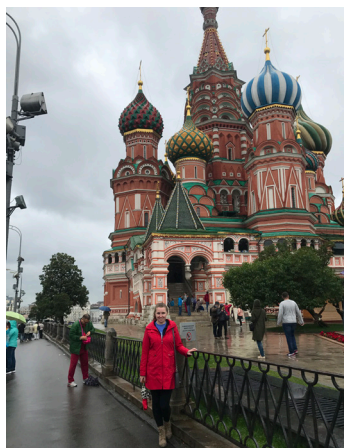

# Build Your Own Internship Program

## Get two for one

With our Build Your Own Internship Program (BYOIP), you can intern with KPMG in two practices chosen from Audit, Tax, or Advisory. One practice provides your “core” experience. The other provides your “developmental” experience in which you’ll work on a variety of client engagements. KPMG is the only one of the Big Four to offer a national split internship program.

## Apply
